III Defendant argues that the trial court erred by allowing testimony from the police officers regarding their investigation of the crime and by allowing testimony that defendant had an extensive criminal record. We disagree. "Generally, evidence of other crimes is inadmissible in the trial of a defendant for the same crime." *People v. Friesen* (1985), 109 Ill.2d 369, 382, 94 Ill.Dec. 592, 599, 488 N.E.2d 261, 268. However, a criminal defendant may not object to the introduction of evidence which would otherwise be inadmissible under the general rule because of the exceptions contained in the rule. *People v.
